



**“Gas Export” Department of State Oil Company of Azerbaijan Republic (SOCAR)  
Changes the dates of announced open procurement competition № 22001-16 in order to ensure its

In this case, the originals of the documents shall be submitted to the Purchasing Organization until the last day of submission of the bids.</p>
